# **MEETING MINUTES**

### Welcome and Introductions

Chair Decker called the meeting to order and welcomed the committee members. DFO Kreps then went through the agenda for the day and the materials provided to each participant in hard copy.

### **Approval of Minutes from Previous Meeting**

The committee approved the minutes from the September 10 meeting as amended.

# **Briefing on EPA's National Recycling Framework**

Rob Vance, Chief of the Resources Conservation Branch of the Office of Land and Emergency Management, briefed the ETTAC on U.S. EPA's new National Recycling Framework. The Framework identifies four strategic priorities: education and outreach; recycling infrastructure, markets for recyclable materials, and measurement. The Framework's launch coincided with America Recycles Week and incorporated recycling-focused Veteran's Day activities held nationwide, the release of U.S. EPA's 2019 Recycling Facts and Figures Report, an innovation fair, and the second annual America Recycles Summit. Vance spoke positively of the event, noting that the first Summit in 2018 recruited 44 participant organizations and this year, the number increased to 177 (more than 300%). ## Market Development Cooperator Program Update

Kirt Gallatin, Director of ITA's Office of Industry Engagement, provided a brief overview of the reinvigorated Market Development Cooperator Program (MDCP). Through MDCP awards, ITA provides technical and financial assistance to trade associations and other non-profit organizations for projects that increase the global competitiveness of a U.S. industry. Kirt encouraged eligible entities to submit applications for 2020 awards, with proposals for funding due April 13, 2020. Several ETTAC members expressed their appreciation for the work done on behalf of the industry by previous MDCP awardees and their enthusiasm about the program's return. ### Discussion with Mary B. Neumayr and Jane Nishida

Mary B. Neumayr, Chairman of the White House Council on Environmental Quality (CEQ), spoke to the ETTAC about the Council and its efforts to improve the performance of the U.S. Government on environmental issues. She emphasized the role of environmental quality in promoting economic growth and security, highlighting President Trump's comments about U.S. environmental leadership and technological innovation. Ms. Neumayr concluded with an acknowledgment of the ETTAC's important work and expressed her appreciation for the committee's recent recommendation letter on the U.S. position in the OECD regarding trade in end-of-life plastics.

Jane Nishida, Principal Deputy Assistant Administrator of the Office of International and Tribal Affairs (OITA) at the U.S. EPA, then briefed the ETTAC on how U.S. EPA is supporting U.S. environmental technologies exports. She commended the ongoing cooperation between ITA and the U.S. EPA on the U.S. Environmental Solutions Toolkit. Ms. Nishida also commented on Administrator Wheeler's international priorities, including addressing marine plastic litter and global water infrastructure and finance challenges, and promotion of U.S. leadership in technology and innovation.

### **Review and Approval of Recommendation Letters**

The Trade Policy and Trade Negotiations Subcommittee shared two draft recommendation letters with the ETTAC for input. The committee voted to approve one letter following up on the ETTAC's September letter in support of the U.S. position objecting to new restrictions on end-of-life plastics trade in the OECD. The committee also approved with amendments a separate letter supporting the Administration's progress in removing Section 232 steel and aluminum tariffs.

### ETTAC 2018-2020 Charter Mid-Term Membership Survey Discussion

DFO Kreps provided an overview of the ETTAC Mid-Term Membership Survey results, highlighting areas where committee members' satisfaction remained high across the last several charters, as well as areas for potential improvement. Chair Decker noted frustration with the lengthy timelines for the Department to acknowledge receipt of the committee's recommendation letters but mentioned that he was heartened to learn that the CEQ Chairman had read some of them. DFO Kreps also requested further information from the ETTAC regarding their use of the SharePoint site as well as the "Buddy System" used to introduce new committee members to ETTAC's work.

## SUBCOMMITTEE READOUTS

#### **Trade Policy and Trade Negotiations**

• The subcommittee chair noted that the group will explore potential recommendations on the Administration's G7 environment-related agenda for the U.S. host year in 2020. It also plans to review U.S. EPA Administrator Wheeler's priorities and discuss the results of the Cooperation on Standards, Certifications and Regulation's recent survey.

#### **Cooperation on Standards, Certifications and Regulations**

• The subcommittee chair provided a brief preliminary readout of the group's survey results and requested assistance from the rest of the committee in conducting the secondary analysis. The chair mentioned that the subcommittee was very satisfied with the survey turnout (71 respondents) and expects to develop recommendations based on the results once the additional analysis is complete. Focus areas are likely to include new E.U. standards as well as cross-cutting issues such as transparency, good regulatory practices, and potentially how to incorporate strong environmental enforcement language in U.S. free trade agreements.

### **Trade Promotion and Export Market Development**

- The subcommittee met with Barbara Farrar and Sam Leon from ITA's Advocacy Center, as well as Cameron Dorsey, ITA's World Bank Liaison, to discuss the ETTAC's September recommendation to host a roundtable targeting challenges facing U.S. companies pursuing Multilateral Development Bank procurements. The subcommittee plans to draft another letter building on the earlier recommendation by providing more detailed advice about execution and focus of the event, including specific suggestions for representatives from the multilateral institutions as well as priority areas for discussion.
- The subcommittee decided to deprioritize the issue of Salesforce CRM interoperability at State Department Partner Posts.
