The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,619.3 million square meter equivalents (MSME) in August 2023, a decline of 5.5 percent compared to August 2022. Imports of textiles were 6,151.3 MSME in August 2023, up 1.3 percent from August 2022. Imports of apparel were 2,468.0 MSME in August 2023, down 19.1 percent from August 2022.

Imports of textiles and apparel were 62,507.8 MSME for the year-to-date August 2023, a decline of 17.9 percent from year-to-date August 2022. Imports of textiles were 46,010.2 MSME for the year-to-date August 2023, a decline of 14.2 percent from the year-to-date August 2022. Apparel imports for the year-to-date August 2023 were 16,497.7 MSME, down 26.8 percent from the year-to-date August 2022.
