The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,405.7 million square meter equivalents (MSME) in September 2023, a decline of 4.5 percent compared to September 2022. Imports of textiles were 6,035.6 MSME in September 2023, down 1.5 percent from September 2022. Imports of apparel were 2,370.0 MSME in September 2023, down 11.5 percent from September 2022.

Imports of textiles and apparel were 70,909.0 MSME for the year-to-date September 2023, a decline of 16.5 percent from year-to-date September 2022. Imports of textiles were 52,040.9 MSME for the year-to-date September 2023, a decline of 12.9 percent from the year-to-date September 2022. Apparel imports for the year-to-date September 2023 were 18,868.1 MSME, down 25.2 percent from the year-to-date September 2022.
