The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,025.6 million square meter equivalents (MSME) in October 2023, an increase of 2.8 percent compared to October 2022. Imports of textiles were 5,998.6 MSME in October 2023, up 7.2 percent from October 2022. Imports of apparel were 2,027.0 MSME in October 2023, down 8.3 percent from October 2022.

Imports of textiles and apparel were 78,896.7 MSME for the year-to-date October 2023, a decline of 15.0 percent from year-to-date October 2022. Imports of textiles were 58,002.3 MSME for the year-to-date October 2023, a decline of 11.2 percent from the year-to-date October 2022. Apparel imports for the year-to-date October 2023 were 20,894.4 MSME, down 23.8 percent from the year-to-date October 2022.
